

21-Aug-06- 7:55pm I am talking with my mother Barb Dunlop and I inform her that at 4:53pm Eastern Standard Time that Maria Malvaso had drove by the end of my street tonight. I said that she has no reason to be in my neighbourhood. I said to my mother I was not sure what she was doing in my neighbourhood. My mom said that she does not need to be in your neighbourhood. I went onto went to my mother ensuring that I was loud enough for my roommate Brad Carne to hear. Brad had just gone upstairs to bed but I am sure that he probably heard. I said to my mother that everybody knows something. I said that it is really unfortunate that one person Maria Malvaso has made everybody jump and they can't figure that out. I said that anybody and everybody who is involved will pay someday, some way. I said that if they regret that they have become involved than that would be good enough. I said I don't care whether it is Kevin Harkness, Brad Carne, Jason Laronde, my dad and Peggy. I said that my next door neighbour (the mechanic has been brought into this). I said that the police were involved in searching my other car. **I said that they do not know that I am investigating them investigating me.** I informed my mother that they do not even know what I am doing. I said that is pretty sad that they can't even catch on to what I am doing. I said maybe they finally have and I just don't know it. I said I have caught onto everything that they have done. I said they are not smart enough. I said they are supposed to

21-Aug-06- be trained investigators. I said that everybody knows something,
7:55pm including, Harkness, Laronde, Shawn (Harwood), dad & Peggy,
Vic Matanovic Jr. and Vic Sr. I said that the unfortunate piece is that
these people have brought my family & friends into it. I said that I do not
care. I said that Kevin Harkness is already a right off and he made the
decision to throw a 27 year relationship down the toilet. I said Laronde is
pretty close. I said that it is really unfortunate but if they have sold me out
as everybody down here has then I will disown anybody and I don't care.
I said that this is all about principal to me. I said that I will not lose and I
will fight this to the bitter end. I said this will last another 20 years if it
has to. I said that even when I lose I don't lose. As I have said before this
will never be about me. I said that my lawyer send me an e-mail back
responding to my questions and said that I would need to give her another
\$20 000 retainer if we pursued action. I said I do not know whether this
was intended for me or whether it was to intimidate me. I said it does not
intimidate me and that I would get her the \$20 000 but first I would
probably look for a new lawyer. I said to my mom that a lawyer that is
looking to make a name for themselves. I said that I will set a precedent
in law. I said that I will fight for others who lose their job and receive
these little settlements. I will make this the most prolific case and that the
Toronto Sun, A-Channel and the North Bay Nugget will be involved from
the start. I said that I will need to get a change of venue for this Mischief
charge as I will never be able to get a fair trial since I rocked 2 police
forces

21-Aug-06- and a Children's Aid Society and I may need a change of venue to
7:55pm Bermuda. I said to my mother between Maria & Maureen trying to bring
me down. I said that there would also be money behind these scenes. I
said that they should all get together for some beers to see if they can keep
their stories straight because I know that they can't. I said that I am sure
they already do get together for some beers to discuss things. I said to my
mother that I can pretty well tell you who is going to call me next between
my friends. I said if I had to guess the next call will probably be
Harkness. (***)Probably not Harkness now if my line is wire-tapped it
may be switched up.) I said that Rick Ramey knows something and I
would not be surprised if Brad Baker in California knows something. I
said Nikki Ramos in Chicago knows something. I said that everybody
thinks something is going to happen this week. I said my criminal lawyer
does not even call me back. I said that I never wanted to do what I have
had to do to protect myself but I have had to. **These people could not
believe that I was standing the last time and they can't believe that I
am standing this time.** I said that I have only defended myself and not
even gone after them. I said they did not let a sleeping giant sleep. **I said
that the North Bay Police can't just beat people up.** I said wait until I
go after them. I said that I will embarrass Maria Malvaso and in turn her
family. I don't care who her dad is. I said I do not know his personality
very well but I know that he has worked hard to get to where he is at. I
said that he works for the Ministry and makes over \$100 000/year. (This
is what Maria Malvaso had told me in the past). I said I just want to put
Maria Malvaso on the stand and even if I have to represent

21-Aug-06- myself. I would tear her apart. I said if they were smart that they would
7:55pm re-interview Maria Malvaos because she would not be able to come close
to what she said in May. I said that I hope somebody is listening because I
would tell it the same way again. I informed my mother that I have
already given up on Kevin and that I have already set him up as well.
I said that if anybody knows he should know that I am smarter. My mom
said that she does not know anything. My mother asked me what has set
me off. I said nothing. My mother said she does not like seeing me like
this. During the conversation I had also said that I am about 2 seconds
away from going public and I will even go to Hollywood.

2. This was also a set-up for Brad to see if he responds, how he responds, if this gets out to others and/or back to me. (Brad would have heard at least some of this if not it all.)

17-Sep-06- 7:44pm I contacted my mother and let her know that I believed the police had changed information of my computer. I said that I had sent information to the Toronto Star and never entered Maria's name. I said that the police have a computer program and they may have cloned my computer. (Brad Carne's computer). I said somebody put Maria's name in the letter. I said that they are going to try and bring her down too or really get me in trouble. I said that this is going to get ugly. My mother said that this was what she did not want to happen.
