03-Oct-06- 9:41am I called Greg McKinnon back from the message he left me the other day. Greg answered the telephone. Greg and I discussed the fact that we had not talked for awhile. I asked Greg where he was. Greg stated that he was in Barrie heading to North Bay. Greg stated that he had not heard from me and he thought that I had fallen off the face of the earth. I asked Greg if he went to the concert last night. Greg said what concert. I said the Aerosmith/Crue concert. Greg stated that he would not pay that kind of money anymore to go see concerts like that. Greg stated that he has seen both bands. Greg stated that Bruce and his wife may have went. Greg and I discussed the Blue Jays a little bit. I said it was good to see that the Jays did not give up the last part of the season. We discussed "Vernon Wells." Greg stated that he hoped for both Vernon to stay on for the Jays to get rid of him because they could get a lot for him. Greg talked about him and Kelly possibly losing \$10 000 for building a house. Greg stated that they have not been able to sell their current house and that the market in Barrie is not all that great at this time with people losing on their homes. Greg also discussed about him and Doug possibly golfing at Bear Creek this Thursday. I left it with Greg to call me either Wednesday or Thursday to let me know what they were doing.
