Steve, John and I continue to discuss my options. Steve states that I need to acquire disclosure from the agency. John suggests that I apply for Legal Aid. The whole entire time there I referred to person involved as "she." I said that this is what she wants because she really enjoys the drama. 8:17pm I received a call at home from John Royal about 5 minutes after I got off of the telephone with Maria Malott. (Ironic?) John said I know I am a pest but when you get back give me a call. John left message on my answering machine.

8:33pm I received a call at home from Steve Rainey right before the all-star to see what is going on, what is going on for the weekend, give you a little update on the other stuff, anyway give me a call at 252-1221, 252-1221 talk to you soon brother.

My doorbell rings and it is Kerri Morris-Goldthorp. I am very shocked to see her and can't believe she is at my door. Kerri says are you going to allow me to come in. I said sure come on in. Kerri asks and my husband to. I said sure. Kirk Goldthorp was parking the van. Kerri then says oh oh do you not want us here. I re-iterated to come on in. I asked her if she wanted a drink and went to get her one. Then went back to door as Kirk entered. Kerri and I embraced in a brief hug. I shook Kirk's hand. I grabbed Kirk, Kerri and myself a beer. Kerri went to the bathroom and Kirk and I went downstairs. Kirk and I sat down and Kerri joined us shortly thereafter. We discussed certain things. Kirk was wondering why I never returned his calls. Kirk said he called me 30-40 times- (exaggeration). I informed Kirk that Maria Malvaso had sold him and Kerri out and since that I was not sure what to think. I said to Kirk and Kerri if you have gone through what I have gone through that you never know who to trust. I said that recently people who work there have sold me out as well. Michelle was dressed up as she had been out. Michelle also had a fancy purse with her. Michelle stated that she had heard that 10:30 was a good-time to get a hold of me. Michelle stated that she had been out earlier with John Royal, Steve Rainey, Karen McCrackeen. Michelle asked me how I was doing. I said that I was fine. I asked her how she was doing. Michelle stated that she was busy. She stated that it was busy at work and that she had been on the Intake work schedule. I said to Michelle that I heard that she had had a card for me about the washing machine. Michelle stated that she did but that she forgot to put a stamp on it. (***)Michelle stated that she had got another card for me and she pulled a card out of her purse.) I opened the card and we shared a laugh. also had a black leather (or appeared to be) purse.

*** Michelle knew that Kerri Morris had been at my residence at
10:30 on the 19-Jul-06.

*** Michelle had a card that Kerri had discussed the night before.
Michelle stated that she had forgot to stamp the first card but she had got
me another one.

20-Jul-06- A copy of the washing machine card from Michelle Bartholomew.

06-Aug-06-
7:05pm I returned Kirk's call about the \$100 from baseball. Kirk stated that he was probably going up north to the camp for a few days as he and Kerri were both on vacation. I said to him well whenever you get a chance give me a call. Kirk said he would be around next weekend as Kerri was in a ball tournament. Kirk said he was around tomorrow, I said I am taking my mother to a baseball game (Blue Jays). I said just call me when you get back. Kirk said that they were having a Stag for Luke Bazely at the Lockerroom tonight at about 9pm if I wanted to go. I said I would have went by my mom's here. (**I would not have went and if this is Goldthorp's way of feeling guilty and trying to get me involved- UNBELIEVABLE) Kirks says I am just trying to keep you involved. You are a good friend Kirk said. I discussed that fact that I needed to get working. I said that it was difficult to get on the pipelines this late in the year. I said that I was trying to get a job on the pipelines with my dad but that also fell through basically because I was not available to work because I had to be available to meet with lawyers and other appointments. I asked Deb how she was doing, she said that she was okay but that she was tired of working for CAS and that at some point that she hoped to get out of CAS. Deb stated that she was a writer. We had a conversation for another few minutes. ***Deb Batt patted me on the back I feel sorry for what happened. I said do not feel sorry. *** Then Deb Batt said "we were all rooting for you" That is Direct Quote.
(I thought to myself you were all rooting for me about What? When? Why? How?...)
