

16-May-06-5:05pm My home telephone rings and I am talking to my roommate Brad Carne about what had just happened with the Barrie Police. The call was from Maria Malott but I do not answer because I do not know what to say to her as I am not supposed to speak to people from work.

16-May-06-5:25pm Maria Malott shows up at my house with a long face. She comes to my front door and I ask what she is doing at my house. Before she answers, I say to her you know don't you. Maria Malott said "yes." I said how do you know. Maria Malott stated that Susan Carmichael, Director of Service had called her into her office. Maria Malott stated that Susan had stated that they were concerned for her and that she felt that Maria needed to know about what was happening to me. *AGENCY BROKE CONFIDENTIALITY. Maria wanted to know if I wanted her here or not because she knew about my restrictions not to associate with people from work. On the spot I decided that I would continue to associate with Maria. I figured that if she was not in on this entire thing then she would be awesome for me to confide in. If she was in on it than that would come out later as well.

17-May-06-
12:00pm Maria Malott rings my doorbell and is distraught. She comes into my house and hands me an e-mail from her ex-partner Chris Powell and asks me to read it. I read it and it appears that somebody from Simcoe C. A. S. has contacted Chris about Maria Malott and I. *This would probably only be Maria Malvaso. Maria Malott and I discuss the email. I ask her if she is O.K. Maria stated I just can't believe that Chris would do this. Maria states that Chris has mental health issues. E-mail accompanied.

16-May-06- This is a copy of Chris Powell's e-mail to Maria Malott.
11:58pm

Just before Christmas Julia and I were playing downstairs and Julia wanted to draw a picture for Santa and so she said Mommy has paper in her room. When we were into Maria's room I saw a pad of paper beneath a silk scarf. When I grabbed the pad of paper there was a hand written letter by maria on the first couple of pages, as I questioned whether or not I should rip off the first couple of pages and hand the pad to Julia who was waiting beside me eagerly I quickly noticed the name Derek appeared several times on the first page. When I read the letter my heart raced to the point of nearly having a heart attack, it wasn't so much that behind my back maria was having lunch alone with Derek, Talking on Our phone with him while I was away, emailing him etc etc... It was her selfish strategy, her thoughts, and intentions behind it all. Thoughts that ended all efforts to fix things and work things out for Julia's sake, those thoughts cheated on both Julia and I.

Just before Christmas and with Julia at my side wanting to draw a picture for Santa was not a responsible time to deal with such a blow, for Julia's sake. With Julia's Birthday coming shortly after Christmas I further pushed out the date in which I would confront maria. I received an unusual call one night on my cell from one of maria's concerned co-workers telling me about how maria is always flirting, going out to lunch, and more.. with someone named derek dunlop at work. I told the person I had known for months but appreciated the heads up. This person then went on to say that they are disgusted someone in a Children's Aid office is doing such a thing and if I really wanted to get maria and Derek back I should email the following people with what was going on:

As I wrote the information down I thought, wait a minute this is another Children's Aid Worker who should have the best interest of my DAUGHTER at heart?. It is Julia's best interest that maria and derek stay gainfully employed and thus the reason I didn't take this persons advice. On many occasions prior to me finding out and many times afterward maria would page me and ask if I could pick up Julia because she was going to be late at work. On Feb 22nd 2006 Maria paged me with such a call, so I picked up Julia and drove by derek's house just on a hunch. Sure enough there was maria's car at Derek and his roommates rented town house, I took a couple of date stamped pictures and told Julia I was taking a picture of a car that looked like mommy's because I thought mommy would think it was neat. maria's hand written letters to herself afterward prove her intention and personal delusion. We are talking about two "CHILDREN'S AID!!!!?????" social workers who's jobs are to do what's in the best interest of Kids, not the exact utter fucking opposite!!!!. Same goes for the other CHILDREN'S AID Weasel who called me hoping I would do what's in the exact opposite of what's best for Julia, because I'm sure it was in the best interest of them in

SURPRISE SURPRISE YOU HAVE DONE THE EXACT SAME THING AGAIN!!!!??? hummm old sayings become old because they are true.....Once a cheater, ALWAYS A CHEATER.

maria, in the first week of Julia dealing with the actual physical separation of her Parent's and everything in between... You have the UNBELIEVABLE GULL AND LACK OF JUDGMENT to talk to her about having a NEW STEP DAD ????. When she came to my house she started sobbing and shaking uncontrollably while she asked me about it. In the best interest of Julia such discussions could wait for A YEAR while Julia adjusts... not in the first GOD DAMN WEEK...???? UNBELIEVABLE!!!. You're the Pro right????!!!! Your horse is the highest of them all.? Integrity, sincerity, and heart should be ingrained in a person and REAL not mimicked... I can see through you like no other, just keep lying to yourself if it makes you happy. It's been interesting and sad witnessing you sneaking around like you're so clever and cunning. You can talk a good story to some but integrity comes when you back it up with action on a consistent basis. You keep doing the exact opposite in many regards with your lack of personal control, TEMPER GALORE!!!, you're screaming and swearing in front of Julia, you're cheating, and putting your needs ahead of Julia's. Pure Selfishness, Just Brutal!!! There is a VERY FINE LINE for derek to walk in terms Julia Grace Powell and her best interest. I will always be in close touch to my daughter and know what's going on. For Julia's sake I don't want maria to feel uncomfortable around my family so I will not be letting them in on all of maria's dark secrets. Also for Julia's sake I will not tell her that her Mommy Cheated on her and her Daddy and put her through all of this when she was just 5 and at the peek of her childhood developmental stage in life. I actually sincerely hope that maria finds someone who she can set a good example of happiness and stability with for Julia's sake, that would be best for Julia.

I am comfortable with who I am and know that I am a good person, from a good family, and most importantly to me I am a great Father to Julia and will continue to be for as long as I live. If you misinterpret anything in this letter as threatening please don't take it that way. The only thing threatening is that Maria is putting her needs before Julia's once again and in

desperate false justification is creating and convincing herself of external excuses for her behavior which will precipitate these actions time and time again.... as it has.

S.- Due to the weather I was not able to complete my pilots license in St. Catherine's this week so I came home early and took Julia to the park and beach today before maria was suppose to pick her up at 5pm. Maria was due to pick Julia up for the night but called my mother and asked if she could watch Julia for the night because she was crazy busy at work and was going to be really late. Julia was excited to stay at my parents house tonight so I left it at that. I really wanted to see if Maria would trade her selfish desires for her time with Julia like so many times before, so I drove by dereks rented townhouse at 10:38pm and sure enough Maria's car was out front just like months before all of this started. maria and derek I have no respect for you what so ever... Just Garbage. You both make me sick, your less then dirty cops... you take people's kids based on your own personal judgment of right and wrong???

19-Jun-06-
8:30pm

Maria Malott and I are watching Game 7 of the Stanley Cup Finals at her residence at 31 Courtney, Barrie, ON. Maria Malott wants to know about disclosure that I have received today. I inform her that there are many lies from what Maria Malvaso has said to police. I said that there is blocked out stuff in relation to Kim Heim. Maria Malott wants to know what information there is about Kim Heim. I said Oh just her telephone number is blocked out. I inform her that Steve Rastin, Lawyer whom I left a message with on the 16-Jun-06 had returned my call and left me a message. Steve had said that he was seeing that I was having problems with the grievance process and also that I was continuing to speak to Andrew Kerr and a lawyer from Aird & Berlis. Steve stated that he was not interested in competing with those lawyers. Steve stated that he was sure that they were good lawyers and that they would do well for me. Steve stated that he would be closing his file and wished me well with this. I also mentioned to Maria Malott that during **our first conversation Steve Rastin & myself that Steve has asked me if I knew which Maria had ratted me out. Maria Malott was somewhat offended by this.** Maria Malott stated that she never wanted to be compared to Maria Malvaso and that she never wanted to be mixed up with her or have somebody mixed them up. *This struck me to be somewhat odd.

22-Jun-06-
10:00pm I have not heard from Maria Malott all day. I find this to be somewhat unusual and this is the first time since we started dating the 29-Apr-06 that it has been this late into the day. I call Maria and leave a voice message on her telephone that I will be up for awhile and to call me back if she wants.

22-Jun-06-
10:25pm Maria Malott calls me back and informs me that she has had a terrible day and that she is not doing that well. Maria Malott stated that she had been just speaking with her friend Gabrielle and that her son Mason had an MRI and that the results were not that great. Maria goes on to speak about Gabrielle's type of skin cancer. Maria said that she had a meltdown earlier and that she cried for about 1 ½ hours. Maria stated that everything has just built up and she feels that it is all hitting her. I inform Maria that I am here for her if she needs me. *I found this somewhat odd to have such a long meltdown.
Maria asks me about myself. I go on to speak about going to see a lawyer in Toronto tomorrow. Maria knows the situation and says are you going to retain her. I said "yes."

Maria states that she is fine. Maria is short with me at times during this discussion. Maria also states that she will often shut people out when she is going through tough times. Our conversation ends at about 11:45pm. Maria had also talked about speaking to supervisor Tracy Johnson about getting time off next week.

- 23-Jun-06-
8:45am I call Maria Malott's cell phone and it goes to the answering voice-mail. I leave Maria Malott a message asking if she has time to go for a coffee.
- 23-Jun-06-
8:50am Maria Malott returns my call and says that she does not hear her cell phone again. (Even a new cell phone now.) *This is strange and she does not appear to her cell phone when I call. Maria Malott states that she was just going to call me. Maria Malott and I agree to meet for coffee at the Tim Horton's on Essa & Ardagh.
- 23-Jun-06-
9:10am Maria Malott and I meet for coffee. During our conversation, Maria Malott apologize for being short with me on the telephone on the 22-Jun-06. Maria Malott states that she is not usually like this. Maria Malott also states that she appreciates my support. Maria Malott also states that she usually does these things on her own and that people close to her sometimes have a tough time dealing with her or supporting her.
(*Lee-Anne Baker- girl from North Bay who now lives in Barrie, I believe, she is in line at Tim Horton's upon Maria and I leaving.)

25-Jun-06-
9:30am My mom and I meet Maria Malott at the Tim Horton's on Mapleview Dr. (By Acura Dealership) at 9:00am. At about 9:30am, Chris Eby enters the Tim Horton's. Chris sees me and comes over to the table. Chris and I have a discussion for a couple of minutes. My mom and Maria Malott are talking and I do not introduce Chris to either of them. After he leaves I inform Maria Malott a couple of moments later that that was Chris Eby. I inform my mom and Maria that Chris says to me that we'll have to connect later. Maria Malott asks me where he is as she said that she had never met him before. (*Another coincidence that Chris was there- I am not sure, I documented it anyway*)

28-Jun-06-7:35pm -Maria Malott does not answer her telephone at home (again).

28-Jun-06-10:25pm Maria Malott and I have a discussion about the computer problems that I am having at home. I said that there is a notification stating that you may be a victim of software counterfeiting. I ask Maria Malott if her ex-partner Chris Powell could have done anything. Maria stated that she did not think so. Maria had previously said that Chris has the ability to effect somebody's Internet service. Maria Malott seemed to be thrown off by this conversation. I also informed Maria that I have been on guard lately as I know something else is going on. I said things have been to quiet plus things are happening. Maria Malott asks what else is happening. I said Steve Rainey called me on the 26-Jun-06 to inform me that the EA committee members had recently decided that anybody who had not paid their dues would be able to pay their dues retro-active as of 01-Apr-06. Maria Malott furthered clarified and said that they had decided (Maria is currently an EA committee member) that anybody who had not paid their dues would still be considered a member and be able to pay their dues retro-active. I said to Maria that Steve had informed me that I could pay them \$11 as a pro-rated retro-active payment. Steve stated that he was waiting on Gary Perdue to make some sort of decision. Steve stated that if Gary agreed to it that if I pay \$11 that I would be an EA member and eligible for pursuing the grievance process. Steve also stated that I would be eligible for \$300.00 from the EA

as support for my legal fees. Steve stated that I would be crazy not to pay the \$11 and get \$300. I said to Maria Malott it is just very odd that this has happened and I do not trust it as Gary Perdue is attached to it. I said that Steve has been good to me but I am not sure if I totally trust him and I am not sure why. Maria Malott stated that she has always had good experiences with Steve and she did know whether she would trust him either. Maria stated she would trust John Royal a head of Steve Rainey. Maria also stated that she has been on guard lately. Maria stated that she is concerned about what her ex-partner Chris Powell is going to do next. Maria stated that she is concerned about how Chris will respond when he finds out that we saw him earlier tonight. What a coincidence when we went to the Subway at Minet's Point and Yonge St. Just before we pulled into the Subway, Maria's daughter Julia states there is daddy. (*I found this to be extremely odd at the time- almost like it was staged.) During this discussion Maria said she wonders how Chris will react because she is sure that Julia will say that she saw Chris when we went to get subs. Maria stated that she is sure Chris will ask Julia who was in the car. Maria stated that Chris did not see us. I agree that Julia will say that she saw Chris when we went to get subs. I went back to my discussion about people who are conspiring against me. I said people are not very smart. I said that I always have been a couple of steps a head of everybody. I said now I am even 5 steps a head of everyone. I said that they all better bury me as I have so much information about so many people and that will all come out.

28-Jun-06-
10:25pm

Maria begins to wipe her eyes and sheds a few tears. I said was is wrong. Maria states that she can not believe all this is happening. Maria stated that the agency would have been just smart to keep me working there and monitor what I was doing. Maria stated that I am vulnerable and that I will fight back. I said that people have kept digging themselves a hole and they have kept digging. I said from the collusion with the police to the conspiracy amongst people at work. I said they are not very smart.

02-Jul-06-
8:25pm

Maria Malott and I were at her residence were having a beer outside on her deck. This was my first beer in about 5 months and I only ended up having 1/3 of a beer. Maria Malott ended up having a discussion about the identity fraud that happened to me. I said to Maria that the day that she had called she never asked me about it. Maria Malott said to me that that had had a couple of years ago. I said to Maria Malott that I had **not** told her that. I said that it was “IRONIC” that the date this happened was the 20-Feb-04 a year previous to the incident with the police in North Bay. I also questioned Maria I said what do you know about this identity fraud. Maria got upset and said that I must have told her during our other conversation about this. Maria Malott stated that she would not be in a relationship with somebody who questioned her and did not trust her. **I said to her that I figured that she would go to the extreme.** Maria Malott went into her house and went upstairs. A couple of moments latter I went into her residence to use the washroom. I went to the washroom and came out. Maria Malott said to me I don't know what to think about what just happened and said to me that she wanted me to leave. (** I figured that if I did questioned Maria Malott for the first time that she would respond this way. – I know that she is involved and I knew that she would react to an extreme extent as it what Maria Malvaso is claiming about me **). Maria Malott goes downstairs into her basement. I ask Maria Malott if she can move her car because she is parked

behind me. Maria can not hear me. I go downstairs and Maria and I agree to talk. Maria Malott is upset that I connect her to Maria Malvaso and Maureen Carrel and the conspiracy against me. Maria Malott states that she is a loyal person. Maria Malott and I discuss this for about a couple of hours. Maria Malott appears to be hurt (*I do not believe this for a second). Maria Malott states that she has stood by me through everything I went through last year and can't believe that I am questioning her. Maria Malott stated that she would never be as cruel as those people have been to me. I said to Maria that I feel bad for questioning her and that I will never allow this to happen again. I said that it is not her and not to take it personally. I said that I am not making excuses but that with everybody against me and everybody lying to my face that I do not have trust of very many people. I said that Kerri Morris, Kirk Goldthorp, Maria Malvaso & Maureen Carrel have all looked me in the eye and lied to me in the face. I also included Gary Perdue's name but I said it was different because I never considered Gary to ever be a friend but the others were supposedly my friends at one time. Maria Malott appears to be better and states that she was not going to walk away tonight. Maria Malott stated that I was the best thing to happen to her other than her daughter (**I do not believe Maria Malott and believe that she is lying).

Maria Malott and I were at my residence. Maria Malott and I had made a bet on 01-Jul-06 driving back from North Bay, ON. Maria Malott stated that her and Connie Joseph had had a previous discussion about me having a Golf Shirt with Pink Stripes. Maria Malott and I had a bet for a 20-minute massage. Maria Malott wanted to go through my closet to examine my wardrobe. Maria Malott and I could find nothing that was pink and definitely nothing that had pink stripes. I said to Maria I have nothing with pink stripes or pink in it. I showed Maria my closed in the computer room with my dress clothes and Dallas Stars apparel. Maria Malott then asks about my dresser drawers. (***) I continue to play a long) I open up my dresser drawers and Maria Malott looks in them. Maria Malott continues to say that she knows I have a Golf Shirt with Pink Stripes on it. Minutes later, Maria Malott goes into my roommates room and said that she was just looking at the pictures and apologized for being nozy. Maria Malott had also said that she had looked at the list of telephone numbers on my table beside my bed. Maria Malott also makes a comment about how disgusting Brad's screen saver is. Maria Malott has made this comment before.

03-Jul-06-
8:45pm

I called Maria Malott back after telling her that I was on the telephone with my mother whom she had called earlier. I asked Maria if everything went all right with Chris and she said “no.” Maria asked how my mother was and I said she was fine. Maria asked if we talked about trades in sports and I said yes. (***It was almost as if Maria had heard our conversation***) While on the telephone with my mom there were pauses. I said to my mom that somebody is listening to my life again and I hope they are having fun (something to that effect). I asked Maria Malott what she was doing. She said that she was writing a journal. I asked her if she was writing a journal about Chris and she said “no.” Maria Malott stated that she was writing about her feelings as this was a way she dealt with her emotions. I asked her if she was writing about what we did today. Maria said “no.” I asked Maria what happened with Chris and she started to say something and then she said are you coming over or do you want me to tell you on the telephone. I go over to Maria’s after we agree to talk about this in person. Maria tells me that Chris did not even walk Julia to the door and that Chris stayed at the end of the driveway. Maria Malott informed me that she and Chris’s mother had to discuss some plans for Julia because Chris would not communicate with Maria. Maria Malott said to me that she thought I found it a bit weird that she was writing a journal about her feelings. I said to Maria Malott that I just hoped that the issues of yesterday were worked through and that that was not what she was writing about. Maria Malott stated that

she was writing her feelings about yesterday. (I found this to be odd.) Maria and I discussed this a bit. (*I felt that I was being set up again). Maria had to go upstairs a couple of times to check on her daughter Julia as something had fallen and made a noise and disturbed Julia trying to sleep. (*There was a notepad with (CAW TWA???) on it in plain view, in the middle of Maria Malott's coffee table by the magazine's *** I said that if this is a set-up then I will bite, I opened the note pad. It appeared to be the first page of a notepad and the sheet was about half a page long. I read the information as fast as I could. Maria Malott talked about going back to work tomorrow after having a week off. Maria stated something to the effect that she felt better. Maria Malott stated that she was unsure about how last night would impact her. Maria Malott stated that I (Derek Dunlop) had thought that she was a part of the conspiracy against me. Maria stated that she could not be with someone who did not trust her but that she loved me so much. Maria Malott stated that she was not sure if the relationship would have continued past last night. (***) This is not word for word as I was reading fast and could not intake information that accurately.)

04-Jul-06-
7:50pm

Maria Malott are having a discussion about the pink shirt or infamous pink shirt. I said to her that I am going to email Connie Joseph about this as she probably will get a kick out of it. Maria Malott stated that Connie Joseph probably will not even remember the conversation. I reiterated that I was going to e-mail Connie Joseph. Maria Malott stated that I better not and she would be mad at me if I did. (***) This is all very odd and just adds to the fact that Maria Malott is involved.)

05-Jul-06-
9:15pm

Maria Malott and I are at her residence and she is in a very depressed mood for the second night in a row. I ask her what is wrong and she speaks about her ex-partner Chris Powell and the e-mails he is sending her. Maria Malott stated that Chris Powell had sent her parents an e-mail saying to disregard yesterdays e-mail as he just wanted to give Maria a taste of her own medicine. Maria Malott and I discuss our situation and she is concerned that because I did not tell her very much information about going to see my lawyer in Toronto (today) that it may be related to the trust issue raised on Sunday 02-Jul-06. I told her know that what I had told her about going to pay my lawyer and talking about the demand letter was the gist of what had happened. We also agree that our earlier discussion had happened in front of Julia and I would not necessarily get into particulars in front of her daughter. (***) I know this was bullshit as she just wants to keep getting information from me. She is another person in way over the heads). I talked to her about getting Maria Malvaso on the stand and said how Maria Malvaso will be eaten alive on the stand. I said to Maria Malott how I hate people who are rats, knowing full well she is a rat. John Royal had returned my call to her residence. John and I discussed the stove I have in my garage that appears to be a hot commodity that nobody wants to buy. John also asked if I was supposed to get back to Steve Rainey about something. I said to John that I thought Steve was supposed to get back to me as he was waiting for Gary Perdue to make a decision. I got off of the telephone and Maria Malott and I discussed this point of me paying \$11 to become a member of the EA and the EA

will give me \$300 in legal support. I once again said to Maria I do not believe it for a second. Maria Malott said I can't believe (Steve Rainer) would be in on this. I said to Maria Malott it is not Steve that I believe would be in on it (This is not true as I believe Steve knows a lot more than he is letting on) and switched the focus to Gary Perdue. I said that I do not believe or trust anything that Gary Perdue does or has and hand in on.

Maria Malott discussed and apologized for Julia pointing to her eyes and then pointing at me and saying I have got my eye on you. Maria stated that this is something that Chris taught her. (***)I do not believe Maria for a second that this is Chris). I said to Maria Malott that I will slowly but surely self-destruct the agency (Simcoe CAS) I said that they want to investigate me. I said that I know what goes on on the inside. I know workers that I can start naming and I also know that they should/could investigate everybody. (***) I know Maria Malott is monitoring my every move.)

Maria Malott discusses about a part of our walk. Maria stated that a car drove by us when we were on our walk and was starring. Maria Malott stated that she could not see if it was Chris or not. Maria Malott stated that Julia and I had our backs to the car. (***)I assuming this was the police.)

I mention the pink shirt or infamous pink shirt. Maria Malott did not respond.

Maria asked me if my roommate Brad Carne had painted his car. I said "no." Maria said he changed his routine. Maria Malott stated that Brad Carne was supposed to paint his car.

Maria Malott and I are playing cribbage. Maria Malott very cocky and giddy for about 30 minutes. At the end of the second game, Maria stated that I do not have a shot in hell. (***)I knew there was an underlying meaning to this as there was an underlying meaning to her cockiness and other statements). I said to Maria Malott that John Royal was taking the serial numbers off of my Gas Stove & Dryer as Nicole Middleton's husband can get parts for appliances as he has his appliance store. Maria Malott said that John is very good with stuff like that. (***)Did she already know this as Maria Malott was also conveniently at my house Rachelle Hamelin was at my house to look @ the gas stove @ 1:30pm on 15-Jun-06.) Maria Malott stated that she did not realize what type of vehicle it was. Maria Malott stated that she could not tell if it was her ex-partner Chris Powell or not. (***)I can tell she if out of sorts) Maria Malott had also questioned me about whether I was going to be going away every weekend. Maria Malott stated that she was sensitive to this as Chris had always gone away on the weekends and that Chris took advantage of this. I have not even gone away for a weekend since we started dating. (***) There was more to this as I believe Maria wanted to know my whereabouts so she could report this to the police).

I came home from running errands and my front door had been left wide open. I am not sure if my roommate Brad Carne is nearby and may have left it open. I thought maybe Brad had walked back up to Food Basics to get his car as Brad has done this in the past when he brought a cart back to the store. Brad's car was not in the driveway. I called Brad's cell phone, no answer, no message left. I made a call to Maria Malott at work to let her know that I was still not sure whether I was going to North Bay or not. Maria's message said that she is in the office today the 07-Jul-06. I left her a message. I was busy at the time and did not go downstairs.
(*** I am not sure if this may have been a set up or not).

- 08-Jul-06-
6:10am I wake up at Maria Malott's residence and I look at the digital clock in her bedroom. It is 6:10am. Maria wakes up at the same time and asks me what time it is. I tell her it is 6:10am. A couple of moments later, I said to Maria Malott that somebody was in my house yesterday. What do you mean?, Maria said. How do you know, Maria Malott said. I said that the door was wide open. How do you know Brad did not leave the door open?, Maria Malott said. How do you know he did not forget to lock it. I lied hear and said I already talked to Brad (I will talk to him later this morning). Maria said to me "That must have freaked you out. (***)Maria had verbal diahhrea and it was almost like what she had said was scripted.) After listening to Maria Malott have virtually no feeling toward this and ask question after question with no cues I got up out of bed and went for a pee in her bathroom, came out of the bathroom got dressed and left.

6:30am I called Maria Malott's house to ask her for her bank account # so that I could deposit the \$800.00 I owe her into her account. Maria Malott did not answer her telephone so I left a message attesting to this fact.

6:40am My doorbell rings it is Maria Malott. I tell her to come in. Maria Malott says to me what the hell just happened. I said to Maria Malott "What the hell do you know." Maria Malott said what do you meant? Maria Malott said, "Oh no you do not think I am part of them." I said what do you know to Maria Malott. Maria Malott said that she knows nothing. I said to Maria Malott I want to go and put that \$800.00 into her account so lets go and do that now. Maria Malott said that she does not care about the money and that she does not want to do that now. Maria Malott said to

Maria Malott said to me that she introduced me to her daughter and I think that she is like the rest of them. Maria Malott said to me that she is not part of them and would never be part of them. (***)I said to Maria Malott- I am going to ask you point bland @ 6:45am on the 08-Jul-06- What do you know?- Maria Malott responds with I do not know anything. I said ok that is fine. I said I really truly hope that you do not know anything because that would be really sick if you did? Maria Malott said I can't believe what you are doing or saying. I said to Maria Malott what were you doing upstairs the other day snooping around. Maria Malott said we were looking for your pink shirt. I also said that you would not even let me e-mail Connie Joseph in relation to this. Maria Malott said fine go ahead e-mail Connie, - I don't care. I said oh yeah it is o.k. for me to e-mail Connie now. Maria Malott said to me that in bed earlier when we talking in bed this morning that I was setting her up. I did not respond. I told Maria Malott to leave my house. She obliged. I asked her twice for her bank account # before she left and she left without giving it to me.

Maria Malott calls me and said to me that she can't believe that this is happening. Maria Malott said that she can't make me trust her. Maria Malott said that she is not involved with this and that she never would be. Maria Malott stated that she would not do this to me and she would never have hurt me this way. Maria Malott stated that people know who she is and that they would not even contemplate asking her to do something like this especially because they see her for who she is. I said to Maria Malott that there are way too many unanswered questions. Maria Malott said that I am in love with you and I have been in love with you for a long time (First time she has said that she loves me). I feel so sad, my heart is broken is what Maria Malott said. Maria Malott said I do not know what to do with myself right now. (***) Maria has virtually no emotion, and there are no tears, no crying and she is just talking). Maria Malott said that I just walked out of her life and that she does not even get an explanation. (***)There was no discussion about the relationship being over- Maria is stating this!) Maria Malott said that I would lay down my life for you. I said to Maria Malott that I have to go and that there is nothing for us to discuss. Maria Malott persists to keep me on the telephone. I said if you are trying to display a pattern there is not one. I said if this conversation is being taped then I want people to hear that it is a not a pattern and that it is everyone else who has the pattern. Maria Malott kept saying stop Derek stop as I was saying this. I said to Maria Malott to tell the truth. I said tell the truth Maria, tell the truth. I asked Maria that if she knew something or knew somebody that knew something for somebody to tell the truth.

7:05am I said to Maria Malott that you are one of them. I said that you fuckers have all try to bring me down but I am still standing tall, standing tall above you all. The other end of the line went blank and there was a buzy signal. Maria Malott hung-up on me.

08-Jul-06-
8:00am I called my roommate Brad Carne at his girlfriend's residence. (Karen Preston). I asked Brad if he remembered leaving the front door open yesterday 07-Jul-06 at about 11:00am. Brad said "no." Brad did say that he remember leaving the stereo on on the main floor level. I told Brad that somebody was in the house at that time. I asked Brad if our home number showed up on his telephone at that time. Brad said "no." Brad did not appear to be that concerned that somebody had been in the house. Brad never leaves the front door open.

08-Jul-06- Brad Carne and his girlfriend Karen Preston came to the house and Brad is basically telling me to go to North Bay. Brad said go for 3 or 4 days- (**like he was trying to push me out of the door and get me out of Barrie, ON.) Brad has been acting strange for awhile. Brad appears to know something or somebody has got to him.

10-Jul-06- Maria Malott sends a letter to my house through XPRESS POST.

Why did she send it XPRESS POST?

Where did she get my postal code?

The next 11 pages are Maria Malott's letter that she sent to me through Xpress Post on the 10-Jul-06.

Dear Derek,

July 8, 2006

It is highly unlikely that you will ever read this, since I really doubt I will send it to you. I'm writing this because I have so much to say to you and you refuse to talk to me. I can hardly believe I'm even needing to write this and I've had all day to start to get over the shock of this morning. I still don't understand what happened this morning and I still don't understand why you questioned me last weekend. It is normal for people to ask questions and as far as I can tell that is all I did, which you seemed to think was odd. I feel like there must be something I am missing or something I don't know about, because for the life of me I can't understand what ever caused you to question me at anypoint. And despite your reassurances that night, I have felt like you were questioning me ever since, which obviously is true, as this morning demonstrates. When I am uncomfortable and scared, which is how I have been feeling with you, I protect myself as much as possible (which I think is fairly normal) which is what I've been doing ever since last weekend. I've been honest and up front about how I've been feeling, and I acknowledge I've been different with you this past week, which unfortunately appears to have reinforced your questioning of me. I think you were right when you said we were feeding off each other's vibes. The result was obviously not good. Part of what's sad for me is that last night I opened up to you even more- I was honest about my insecurities and my fears and I felt better after talking to you- I didn't know that you were questioning me even then. When we went to bed, I just thought you were tired and

figured that's why you weren't initiating physical contact (plus I was basically out of commission, so I figured maybe that was why too). Now I realize you were questioning me. This morning you totally shocked me when the first thing you said was someone was in your house yesterday. I just woke up & it was pretty clear that there were questions/hidden meaning behind your words. I didn't know what to say or how to handle that, plus I just woke up. I was absolutely shocked when you got dressed & walked out for no apparent reason. In case you care, which at this point, I have to assume you don't, but too bad, that is the moment you broke my heart- just ripped it to shreds. I knew right then that you don't trust me, although I don't know why. I have done everything I can to support you through this, Derek, despite having a whole lot on my own plate. I have stayed with you despite my fears of how this could potentially hurt me and my daughter. I have never shared your business with anyone unless I had your permission to do so. (I talked to Jane and Gabrielle, but kept it very brief-and I asked you first.) I can't believe I'm even going to write this, but I will- I have never, would never, done anything to hurt you. I have never and would never talked to Maureen, Maria Malvaso or anyone else in that group about you or anything else for that matter. The only time I have any contact with those people is at work and for work purposes only. I hate them for what they've done to you, for what they've done to me, but most of all for what they've done to us. The fact that you can

even think that I could be part of that offends me to my deepest core. I'm not sure that I can ever forgive you for that insult as it is so deep. The fact that you spoke to me today the way you've told me you've spoken to Maria Malvaso hurt me more than I can ever adequately express here. The fact that you honestly believe that I could do such heinous things is beyond my comprehension. You should know me Derek- you've known me since last August/September and you should know better. I would give my life for you, Derek, if I had to. I love you and I have for a long time. I am the most loyal, honest and trustworthy person I know and I felt I had met my match in you- in all those qualities and so many more. I was planning my life with you I introduced you to my daughter, which is beyond huge for me. I'm sure you realize that you how you could think I could do this to my daughter too is also beyond my comprehension. By cutting me out Derek, you have given them exactly what they wanted. They want you to be isolated and they certainly don't want us together. Congratulations, you let them manipulate you- I am bitter and pissed off too, but mostly just sad. So incredibly sad.

So now I have questions for you: What on God's earth do you think I would ever get out of betraying you (besides a broken heart)? How could you possibly think I would introduce you to my daughter if I was betraying you (how could you think I would introduce her to anyone I don't think is incredibly important to me)? How do you think any of this transpired, given I have

never been friends with these people and I rarely leave my house unless I'm with you? By the way, you are welcome to check my cell phone & my bell bills-there is nothing to see on either. You have seen my house & my clothes, obviously I don't value material goods very much- My car is old & not even running all that well anymore. What motive could I possibly have to hurt you, Derek? Money sure as hell won't do it. Material goods? Obviously not. You tell me. You have thrown away an amazing relationship, with a huge connection and real love, based on what? I'm not even sure. All I know from what you've told me is that you felt I asked too many questions & I acted funny last week. That's another thing, Derek when have I brought up the whole thing to you? When have I pried or really asked for details about stuff? I mean things that could actually be useful to the other side, such as the names of your lawyers or what your strategy is going to be- I haven't brought it up, I've asked very few questions, I've just listened for the most part when you've talked and tried to be as supportive as I can. **I've left your written material alone, for the most part, Derek except when you've told me to read something and that one day when I started reading something on your table without asking or being asked I realized what I was doing & stopped myself.** That is the only time I've read anything without being asked, Derek, and I told you at the time & apologized for it. That brings me to the pink shirt thing- you said that this morning – we were looking for your shirt

with the pink stripes, which I swear I saw you wear before, but in all honesty Derek, I used to have so much trouble even looking at you that I realize I could be wrong. I'm not sure if it was the same day that I was looking on your dresser- I have a feeling it was & I'm guessing maybe that's what you were talking about this morning- it took me all day to realize that. Looking on your dresser is just normal girlfriend stuff, Derek- every girlfriend does it, they just don't usually tell their boyfriends. I really didn't think anything of it- I was curious about what you had up there & figured we were at a place where we could handle it, relationship-wise. I also figured you are so open about all your past relationships that I didn't think I would find any surprises on your dresser (ie naked pictures of ex's, phone #'s etc). I refuse to monitor every step I take because of what's happened in the past to you. (Although I recognize that at this point, it is probably a moot point). It's normal to check out what your boyfriend has in his bedroom. In terms of emailing Connie, if you must know, I was jealous that you would email her and not me. I'm not at all proud of that, but it's the truth e-mail was our thing & we had it ripped away from us. I didn't want you to email joking emails with someone else, not even Connie. It may have been selfish & immature of me, but it's not twisted, Derek like you made it out to be. You have misread so many things, even when I've explained myself, based on your past relationship. I am not Maria Malvaso

and I absolutely do not deserve the treatment you have given me today or last weekend. I have never done anything to hurt you and in fact, I've done everything I can to love you, support you and help you through this. And in return for that you have hurt me more than I can express. I said to you before and I will say it again, my life is an open book to you. You can come here & look through everything, even my journals, which are sacred to me, I have no secrets to hide from, you, Derek. You can do that even despite the fact that it appears that our relationship is over.

I called you tonight, against my better judgement (after what you said this morning, I didn't even know if I'd be willing to speak with you again at least anytime soon, to be honest), because I decided I couldn't just let you throw us away without at least trying to talk to you. I know damn well that if you really believe that I am part of the conspiracy that you will think I am trying to keep up contact with you for their purposes hell you probably think that about this letter too- I'm starting to really think I might send this to you- hell you'll probably even read into that, but you know what, I called you anyways because I am not going to live my life that way- thinking about all that stuff then responding accordingly. I'm living my life the way I always have, so I called you because I would never in my life let someone throw this away without at least trying to make contact. It really hurts that you haven't called back. I am so sad that you won't even talk to me. I love you Derek. I have never done

anything to hurt you and I never would. I am not sure how I'm even going to get over you and I can't even believe that I have to try. I want you to know too, that your comment about lack of emotion this morning could not have been more wrong- I was in complete shock then Derek & I'm not one for dramatics at any time- you should know that about me too. But the emotion was very much there.

I would really like to talk to you in person so I can at least wrap my head around this a little bit. But I will not keep calling, nor will I come by your house uninvited. I will respect your wishes. I remind you again that I am not Maria Malvaso.

If I hear from you, that will be appreciated, at least I think it will- I'm really scared of how painful it will be to talk to you- how the hell did we end up here, Derek? If not, well that is almost unbearable to me.

I don't know what else to say, so I will end the letter here. I hope to hear from you.

July 9- I may stop by your house this morning just to see if I can at least give this to you but I won't keep doing that. Yesterday was one of the worst days of my life. I have never felt this way about anyone else Derek and I've never wanted something so much as our relationship- you are everything I've ever looked for and I was so happy to find you. Yesterday floored me. It was so unexpected. I am truly heartbroken, Derek.

July 9, 2006

I just went to your house. Your car wasn't there, but Brad's was so I rang the doorbell to see if I could at least ask him to give you this letter. He didn't answer the door, which I can only assume is because it was me standing there and I'm assuming you've told him your suspicious about me. I can't tell you what it feels to be persecuted when I've done nothing wrong and in fact, I've done as much for you as I possibly could. The fact that you're not there probably means you're trying to avoid me and that scares me because maybe that means you've made up your mind about me, even though it's all based on conjecture. All I can do right now, I think is just love you and hope you'll come to your senses and realize how crazy this is. I keep hoping you will realize it and come here or at least call me. I can't stop crying and I honestly don't know how I'm going to get through this.

I've totally put myself out there in this letter, which is not easy for me to do, but you're worth it, Derek. I guess you will do with it what you want.

I love you.

July 10, 2006- I'm sending this letter today. I am starting to feel very angry at you for what you have done (thrown our relationship away) and for how you have treated me. I want to clearly say to you that you just threw away the best relationship I've ever had and from what you said, you've ever had, because we had a bad week! And you decided that my

behaviour had to be attributed to being involved in that conspiracy against you. Despite all the contra-indicators I've already pointed out to you in this letter. That's as crazy as me saying that your behaviour tells me your in cahoots with Chris and spying on me to get information in case we go to court. Everything was going great for us, Derek, as far as I could tell anyways, and then God only knows what happened last weekend to cause you to question me. I can only assume you've been looking for reasons not to trust me. If you look hard enough for something like that, Derek, you will find it, whether it's real or imagined. Chris deciding that I cheated on him is a great example of that. My behaviour last week was based primarily on my feelings towards you after what happened last weekend. I was scared, hurt and pissed off at you. Add to that the fact that I was averaging 3 hours sleep a night last week, and I was pre-menstrual on the patch which I'm now pretty sure was messing me up a bit too, and no wonder I was acting differently. You were acting differently too, Derek and that's despite your promises to me that you would never do what you did again- falsely accuse me. I was pretty honest & up front about how I was feeling and you should have been able to see it for what it was & cut me some slack for a week. Instead, you accused me of heinous, horrible things- you are supposed to know me Derek! And you are supposed to care about me. You have offended me and insulted me so very deeply. I am devastated and heartbroken and I miss you so much, and for

what reason? I still cannot believe this has happened. And I can't believe you just walked out of here yesterday, no my God it's been 2 days- Saturday morning without even talking to me. I deserve better than the treatment you have given me. A lot better.

I never thought you would hurt me like this Derek. I absolutely believed that we were going to spend our lives together and I was so happy to have found you. I asked you this past week if there were things you wanted me to do to help you through this trust issue, you said no. If you would have asked, I would have been willing to do just about anything (within reason) ie you could have asked me to always be available by cell (even during interviews) or asked if it was ok to poke around my house or whatever- if me working at the agency was an issue I would have seriously looked into finding another job (bearing in mind finances may have been a sticking point), all you had to do was ask. I would have worked with you through this-because I recognize you've been through hell. But unfortunately, it would appear to me that you didn't trust me enough even to ask. And I took your word at face value and carried on with my life and now realize looking back how you would have looked at me being in Orillia on Friday & I was kind of weird when I called you because I felt uncomfortable & I was upset with you because you never gave me a solid answer about the weekend & I felt like you weren't valuing me & meeting my parents by not doing that. I guess I'm at fault too for

not being honest about that, but I wasn't sure how much more we could take, given how tense things were. I should have talked to you about it & for that I apologize. My point is this- you took my behaviour to mean something sinister when in fact it was related to our relationship. I'm not sure if you've been questioning me all along-it makes me so sad to think about that, but if you were, I definitely have my own share of relationship issues so I am sure I've provided fuel if you wanted to believe such horrible things about me.

I cannot make you see the truth, no matter how much I would like to. You will believe whatever you choose to. I had to write this letter to you, though, to say the things I wanted to say. I never had a chance to actually say them to you. I hope you will at least consider what I have written.

I love you Derek- I never got to say that to you in person either. I love you with all my heart.

I told him that Maria Malott was making it very difficult for me to meet her. Brad suggested that I get a money order and send it express post. Brad jumped on this like he knew something and that he wanted me to do this. Brad said that I should not make any contact with her. I said I realize that but I want her to get her money back. I also told Brad that I did not trust John Royal and I was not going to go to Manitoulin's. I said I did not know if I was going to call either Steve or John. Brad said you should at least call Steve or John. (***)Brad does not care about stuff like this- This is very odd for him.) I also mentioned to Brad that Steve wanted to talk about the EA dues where I would pay the agency \$11 and get \$300.00. Brad said to tell Steve to stuff that money. Brad continues to be very curious about what is going on. Brad wants me to call Vic Sr. It is almost like it is scripted. I told Brad during our discussion especially when I am talking that he is really quiet.

I call Maria Malott at home. Maria Malott is shocked to hear from me. I want to discuss with her arrangements to get her her \$800.00 back and her book the Da Vinci Code back. I said at one point that I wish I did not even discuss things with her last year. Maria continued to want to discuss the issues of why I walked out on her on Saturday 08-Jul-06. She said it was not fair. Maria kept wanting to talk about the reasons why I do not trust her. Maria Malott stated that she did not understand. I kept saying that I do not want to discuss this with her. ***Maria would not agree to meet me tomorrow or Thursday to give her her money as she has her daughter Julia both days. Maria Malott would also not agree to meet with me at lunch time and then go back to work as that would disturb her day and then effect her work. Maria Malott would not agree to meet me Friday at the bank or anytime over the weekend as she had a friend coming to her house. I asked Maria is she would take 5 minutes of her time to meet me at the bank during the weekend. Maria Malott stated that she did have time would not leave her friend and that she had Julia on Saturday.
