I did not want this to be a sad song about me but even when I write it, it is very difficult to put much of a positive light on it. This is very small part of the entire story.


The bottom line is that I have a short list of about 500 witnessed who may have to testify in this case. Many of them will have to perjure themselves, especially her. She is a pathological liar.


