Dear Ms. Konstantos:

On 15-Jun-14, Jason Konstantos asked me to do him a huge favour and provide him with a significant loan of money. That day the 15-Jun-14 ended up being the last game of the NBA finals with the San Antonio Spurs winning the NBA Championship. Jason and his son Peter watched the game at a bar called Mugshots that night. I met up with Jason and Peter shortly after the game was over. Jason drove me home to my place and I agreed to loan Jason \$1 750.00 which I provided to Jason in my driveway and his son Peter was in the passenger's seat at the time. On the 15-Jun-14, Jason notified me that he would be able to pay me back this money as of Tuesday the 17-Jun-14. On the 16-Jun-14, I received a text from Jason thanking me for loaning him the money. Jason asked me if I could double what I lent him and I said no but I could probably lend him another \$1 000.00. I informed Jason to call me on the evening of the 20-Jun-14. Jason contacted me on the evening of the 20-Jun-14 and we arranged to meet at the Yorkdale mall around 8pm and at that time I would loan him another \$1 000.00. I met Jason at 8pm at Yorkdale and loaned him another \$1 000.00 making the total that he owes me was now \$2 750.00. Jason told me that his fiancée (Marcy) was waiting in the vehicle. Jason also told me that the first thing he was going to do with the money I lent him was to pay Marcy back for paying for the hotel room(s) at the Eaton (Delta) Chelsea in downtown Toronto.

On the 20-Jun-14, Jason informed me that he would be able to pay me back next week (being the basically the last week of June and by the latest the 30-Jun-14 in which his house was closing.

I loaned this money to Jason as a friend and I thought that his word would be good for it. Jason portrayed to me that he was in need on both of these occasions, so I was willing to help him out. Jason has not even had the decency to contact me by telephone to inform me what is happening with the money he owes me, let alone paying me back.

I have heard a lot of stories about Jason Konstantos and his deceitful ways, but now it appears I am experiencing and encountering it first-hand. It appears that Jason may be a pathological liar.

Please provide to me Jason's new address and any other contact information. I know he resides at an address of 151 something and I believe it would be categorized as being in the North York area. Jason is residing in a home that is valued in the vicinity of \$900 000 and is driving a Lexus SUV. It appears that Jason may have used the money I lent him to put down on the closing of his house.

I really do not want to have to pursue civil and/or criminal action against Jason Konstantos. I am dumbfounded that it appears that Jason appears to have no conscience about this.

At the very least, please contact Jason and let him know to contact me.

Please notify me who Jason's current attorney is, thank you.

I have received information from Ms. Helen Konstantos that at a recent bail hearing for Mr. Jason Konstantos that a Detective Lee testified that Det. Lee had spoken to me.
